

RULES: SSX INVESTOR REFERRAL PROGRAM

Version 3.0

Date: July 15, 2015

DEFINITIONS:

Verified Investor: A registered investor with SSX Brokers N.V. who has completed the Know Your Customer SSX Investor Verification Process and has been deemed by the compliance staff of SSX Brokers N.V. as verified.

New Verified Investor: Anyone who becomes a Verified Investor during the Program Period.

Investor: Either a Verified Investor or a New Verified Investor.

Investor Account: The online account of a client of SSX Brokers N.V. This account allows a Verified Investor to purchase stock offered by SSX Brokers N.V. online via the website <https://investors.startup.sx>.

Trading Credit: The reward that the Verified Investor receives from the Program during the Program Period for satisfying the requirements of Program. The Credit has no value and is not valid until it is applied towards the purchase of Stock via SSX Brokers N.V. Credit cannot be used for anything more than the purchase of Stock via SSX Brokers N.V. during the Claim Period and has no cash value.

Credit: See the definition of Trading Credit.

Normal Funds: Any funds in the Investor's account which are derived from the transfer of money from the Investor's bank accounts or other sources, or from the sale of stock on SSX Brokers N.V.

Conversion of Trading Credit to Normal Funds: Conversion takes place when stock purchased using Trading Credit is sold on SSX.

Deposit of Credit: Credit will be available in the SSX Account within 48 hours of the terms of the Program being satisfied for each individual client. For each credit applied an email will be sent to the client. To verify a deposit the client may access their SSX Account.

Withdrawal of Credit: Credit has no monetary value outside of the SSX System and thus can not be withdrawn until Conversion to Normal Funds.

Unique Referral Link: The Referral Link that is specific to each client of SSX Brokers N.V. and is used to track affiliates. The unique portion of the link is the client's SSX Username. The link has only two formats that can be used. Only these two formats will allow SSX Brokers N.V. to properly record the Referral.

The Referrer: Any SSX Investor who has shared their Unique Referral Link with non Investors via public or private means.

Affiliate: Any person who clicks on a Unique Referral Link and then proceeds to register with SSX Brokers N.V. while the affiliate cookie remains on their computer to a maximum of 30 days. Once they register with SSX Brokers N.V. then the owner of the Unique Referral Link is designated as the Investor's Referrer.

Referral: The action taken by the Referrer to recruit the Affiliate to the Startup Stock Exchange.

The Program: A word used to describe the SSX Investor Referral Program 3.0. The Terms and Conditions are unique from The Program defined in Version 2.0 and may be unique from a future Version 4.0.

SSX Investor Referral Program: A promotion that will award any Referrer that is a Verified Investor the amount of \$20.00 USD of Trading Credit for each new Affiliate who is deemed a Verified Investor during the Program Period.

Program Period: The period that commences August 18, 2015 and is scheduled to end on December 31, 2015. The Terms of the Program are unique during this Program Period. SSX has the right to end the Program Period at any time prior to the scheduled end date.

Rules: These are the rules regarding the SSX INVESTOR REFERRAL PROGRAM 3.0. The Rules may be amended at any time by SSX Brokers N.V. and any changes will be deemed to have been given proper notification to Investors when they are published on the SSX website.

Claim Period: The limited period of time in which credit earned during the Program Period can be used to purchase stocks on the DCSX via the brokerage services of SSX Brokers. This period of time ends on December 31, 2016. Any Trading Credit that was not used by the Investor during the Claim Period will expire and no longer be available for use by the Investor.

Trade: The buying and selling of stock on the DCSX via SSX Brokers N.V.

Stock: All Stocks publicly listed on the Dutch Caribbean Securities Exchange (DCSX) and offered for sale via SSX Brokers N.V.

Share: See Stock

Valid Participants in the Program: The Program is only available to SSX Verified Investors in countries or states where this Promotion is legal and to only those who are eligible for trading with SSX per the Terms of Use and Brokerage Agreement of SSX Brokers N.V.

Referrals

A Unique Referral Link is available to each SSX Investor allowing them to be a Referrer.

The Referrer must use its Unique Referral link to refer Affiliates to SSX.

The Referrer and The Affiliate both have to use the complete Unique Referral Link for the Referral to be accounted for.

The Referrer is responsible for distributing its Unique Referral Link to their contacts.

SSX is under no circumstances responsible for Unique Referral Link that was edited, altered or changed in any way by either the Referrer or the Affiliate.

SSX will honor no claims from Referrers or Affiliates who have edited or altered the Unique Referral Code.

Restriction on Referrals

Each Referrer is allowed to distribute his Unique Referral Link as often as he or she wishes. However, only the first 100 Verified Investor Affiliates per Referrer will earn Credit as part of The Program. After that, the Referrer can no longer earn Credit from The Program. SSX has other programs for Referrers who have more than 100 Verified Investor Affiliates. Cookies

SSX uses cookie technology to record the Unique Referral Link of The Referrer.

Cookies only work as long as the Affiliate does not remove the cookie from his internet browser prior to registering at investors.startup.sx/registration

SSX, under no circumstances, is responsible if the Affiliate removes his cookies prior to registration or has cookies turned off on the browser, making it impossible to record the Unique Referral Link at the moment of registration.

Fraud

Any form of fraud may automatically disqualify the Investor or Affiliate from participation in The Program and any credit given to the Investor shall be cancelled.

Whenever fraud is suspected, SSX is authorized to freeze any Credit the Investor has already received into his Investor Account during The Program, and re-audit any Referrals that have already been admitted into The Program

Questions

Any disputes about Credit, questions or requests from Referrers have to be made in written form through affiliateprogram@startup.sx

Each question or request will be investigated by SSX. During the investigation, the Referrer may have to provide proof of the marketing material, processes, and clicks through to the Affiliate Links for the Affiliates in question. After investigation SSX will rule on the question or request and inform the Referrer about the ruling.

Under no circumstance does questioning or requesting more information imply or give the Referrer the right to compensation of Credit or to compensation in any other form.

Limitations and Exclusions

SSX has the right to exclude anyone from participation.

SSX has the right to limit the number of total Referrals from any Referrer.

Investors can only participate in one SSX Promotion or SSX Program at a time. If any other Promotion occurs during the Program Period Investors already participating in this Program are excluded from other Promotions.

Once the Program Period ends, Referrers are not eligible any more to receive Credit from Referrals who have their account verified, even if these Referrals use the Unique Referral Link.

Other

In any case that the above rules don't foresee in a circumstance, SSX is allowed to rule on any issue. This ruling is binding.
